## Information Clause for Job Applicants

  Commercial Division of the National Court Register under number 0000841472, NIP: PL7861702138
  (hereinafter NATOM).
- 2. In matters related to the processing of your data by the Administrator, you can contact us using the above data or with the Data Protection Coordinator appointed by the Administrator at the email address: biuro@natom.pl.
- 3. Your data will be processed for the purpose of conducting the recruitment process, based on labor law regulations (Article 6(1)© GDPR). Data not required by law, provided by you in the submitted documents, will be processed based on consent, which will be considered given by submitting them (Article 6(1)(a) GDPR). Additionally, your personal data may be processed for purposes related to future recruitment processes, based on separate consent given by you.
- 4. In the scope of information indicated in the announcement as necessary, in accordance with the Labor Code providing data is mandatory and necessary to participate in the recruitment process. Failure to provide them may prevent participation in the recruitment process. Providing data other than those indicated in the announcement as required does not affect the recruitment process and is not necessary.
- 5. Consent to the processing of personal data can be withdrawn at any time without affecting the processing that took place before its withdrawal.
- 6. Recipients of your personal data may only be entities authorized to receive them under the law.
